(depending on income decision, receipt, bank statement or proof of payment must be attach)

- **Salary** (shift and seasonal supplements, fringe benefits, daily allowance, holiday pay etc.) – **attach** salary statement

- **Daily allowances and compensations paid for on basis of accident insurance**
